**Terms and Conditions for the Empanelment of Faculties for HSRT Programme,  
conducted by GMVN for the FY 2017-18**

Garhwal Mandal Vikas Nigam Limited (GMVN) is a Govt. of Uttarakhand undertaking, started in 1976 and having its presence in more than 80 locations. We have also been running very successfully “Huner se Rozgar Tak” (HSRT), a programme of Ministry of Tourism, Government of India for the last 5 years and have trained more than 17,000 trainees so far under this scheme. GMVN Ltd. Requires Qualified and Experienced Faculties, to be Empanelled, for the Training of the students enrolled under HSRT Programme, to be conducted at various locations of GMVN.

The Empanelment of Faculties would be purely on contractual basis till 31<sup>st</sup> March, 2018 or till the project period of HSRT Programme 2017-18, whichever is earlier. Their Empanelment would not be considered as an appointment at GMVN. **Qualification and Experience for FACULTY-**

- A Three-year full time Degree Course in Hotel Management & Catering Technology from any recognised College/ Institute and 3- years of experience in any sector of Hospitality/ Service Industry.

Or

- A One-year full time Diploma Course in Hotel Management & Catering Technology from any recognised College/ Institute and 5- years of experience in any sector of Hospitality/ Service Industry.
- The candidates with prior experience of HSRT would be given preference over others.

**Scope of Work-**

- Conduct Theoretical and Practical classes for HSRT Trainees in allotted unit/ units.
- Maintain registration record of each batch of HSRT in allotted unit/ units.
- Preparation of Results and Certificates for the passing out students of HSRT in allotted unit/ units.
- Maintain any other document/s or any other formality as desired by the Management of GMVN Ltd.

**Remuneration-**

- The Faculty would be paid a fixed honorarium/remuneration of Rs. 500/- per day for a session of 8 hours (Theory and Practical).
- TA would be given on “As per actual” basis during any travelling required for the project, with the prior permission of the Management of GMVN.
