### 24) <u>RESOLUTION OF DISPUTES/ ARBITRATION</u>

If any dispute arises in reference to any word, meaning, terms and conditions, or to the right and liabilities of the parties to the agreement or for any type of payment, or any dispute what so ever arising out of this agreement will be referred to the Sole Arbitrator, appointed by the Managing Director and whose Order/Award will be full and final and shall be binding upon both the parties. In such reference the Rules and Regulations framed as per the provisions contained in Arbitration and Conciliation Act, 1996 will be effective and applicable and the place of Arbitration shall be at Dehradun.

### 25) <u>PENALTIES</u>

# <u>PAYMENTS</u>

a. The bill with stock entry duly verified by Manager/In charge to be submitted by supplier in duplicate for payment. Bill will be paid on monthly basis after proper supply of materials as per approved sample, stock entry of materials. b. Certificate from the Inspecting Authority as appointed by GMVN Ltd. shall in no way relieve the supplier for any loss, injury or damage, which may result from the use of improper material or defective workmanship which might have escaped the attention of the Inspecting Authority. The Successful bidder shall also be liable for the replacement of the improper material and attending to the defective workmanship.

c. Payment will be made after successful inspection of the item supplied matching with the sample by the authorized person appointed by GMVN Ltd.

### 27) <u>INTERPRETATION</u>

### 28) <u>JURISDICTION</u>
