- 5. References of at least three EPF trusts where the applying agency/ firm has rendered their services Advisory Assignments towards Sale of Securities including for Portfolio Churning for Retirement Trusts from PSU/Government affiliated entities for which advisory services are provided.
 - (Preference will be given to the party having reference of PSUs or Government managed EPF Trusts)

- 6. The applying firm should have valid Registration with SEBI
- 7. The party/ firm applying should have a Net worth of at least Rs 25.00 crores P.A. continuously for past three years i.e., 2021-22, 2020-21 & 2019-20 or Average Net worth of at least Rs 25.00 crores P.A. for past three years as mentioned above. (Certified copy of Final Account duly attested by the company as proof should be attached for verification)
